The Parties, The Principal, Shirpur Education Society's, H. R. Patel Institute of Pharmaceutical Education and Research Shirpur Karwand Naka, Shirpur-425405 and The Director, Infinite Biotech Institute of Research and Analytics Sangli, F2 Shivshakti Plaza, Vishrambhag, Sangli - 416416 are signing Memorandum of Understanding (MoU) for Academic and Technological Exchange, today on 31 July 2023 and will remain in force for Five years.

The Parties means, The Principal, Shirpur Education Society's, H. R. Patel Institute of Pharmaceutical Education and Research Shirpur, Karwand Naka, Shirpur-425405 and The Director, Infinite Biotech Institute of Research and Analytics Sangli, F2 Shivshakti Plaza, Vishrambhag, Sangli - 416416. 

### 1. Objectives:

- The Parties intend by this MoU to ensure a mutually beneficial partnership.
- The Parties, based upon the principle of respect of each other's independence and of mutual benefit, will carry out the following activities collaboratively.
  - i) Exchange of Students for Workshops
  - ii) Exchange of Faculty and Research Students
  - iii) Use of Equipments and Infrastructural facilities (On Mutual Understanding)
  - iv) Use and share libraries, database, documentations
  - v) Undertaking Joint Research Activities
  - vi) Organization of seminars/workshops and to arrange career counseling and placements as well.
  - vii) Sharing of human intelligence in academic as well technological sectors.

### 3. ROLES AND RESPONSIBILITIES OF THE PARTIES:

- The Parties may shall jointly undertake academic and research programmes. They agree to the use of the experimental database generated by the joint project under this MoU. Output for collaborative research activities shall be published under joint authorship.
- Both parties shall constitute the committee to steer various activities of the MoU. The Principal of the College will be chairperson and senior staff of beneficiary department may be the member secretary of the Steering Committee. They shall meet at least twice in academic year.
- The Parties may formulate perspective plan and the Standard Operating Procedure (SOP) for its execution.
- In the implementation of the co-operative activities, each institution shall build on their respective strengths and shall clearly identify the roles in developing and implementing the projects.
- Funds raised for a specific purpose of agreed joint activity should be managed and expended to the mutual satisfaction of both the parties.
- Any amendment in the MoU draft shall be made after consultation and mutual written consent.



- With mutual consultation, the Parties can terminate the MoU.
- With mutual consultation, the validity of the MoU may be extended
- Share information with confidentiality as the main clause which does not harm the participating organizations.
- Create better working environments and better academic practices through collaborative projects.
- The issues with intellectual property right can be shared only with prior permission of the both parties
- Amendments, if any, in the MoU may be made in writing and signed by both Parties.

#### 4. Financial :

- A Major objective is to establish common platform for academic and research activities.
- The Parties shall not demand any monetary charges from each other for the use of research protocols, teaching training, research and development.
