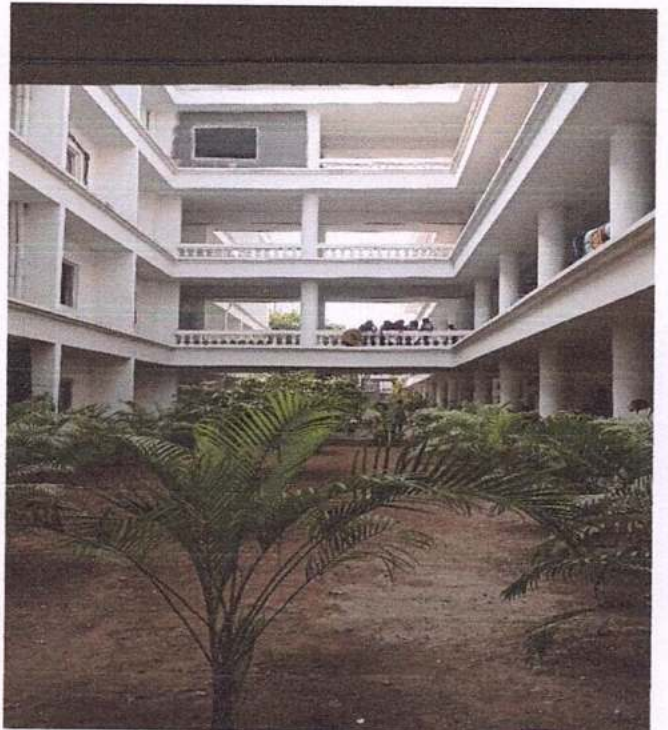

II Executive Summary

The premises were evaluated against the various criteria laid down by the National Assessment and Accreditation Council (NAAC). The major observations are:

Air Quality & Ventilation:

- The classrooms and other areas are well ventilated to ensure proper air quality.
- The fans are appropriately installed to ensure proper air circulation.
- The outdoor and few indoor plants have also been provided to improve the environment.
- The air conditioned rooms are provided with proper ventilation and fresh air.

Lighting System:

- The usage of natural light is optimized through well designed structure and windows.
- Almost all the light fittings are provided with high efficiency LED lamps, the others being replaced with LED lamps.
- It is suggested to automate switching of lamps in the common areas and rest rooms with sensor based control.

Green Campus Initiative:

- The movement of vehicle inside the campus is restricted and sufficient parking space is provided for four as well as two wheeler vehicles.
- The plastic usage is completely banned inside the campus.
- The campus is surrounded with a lot of greenery, trees, and proper landscaping.
- The college has various groups to create awareness and take up activities like tree plantation, cleanliness drives, road shows and other awareness programs.
- The student participation is encouraged in such activities through student clubs and groups.

Environment & Energy Initiative:

- Tree Plantation drive was undertaken by students and staff members.
- Cleanliness drives were undertaken by students and staff members.

Water Quality & Conservation:

- The water is supplied by the Corporation, which is a common practice in cities and towns.
- The RO (Reverse Osmosis) based water purification system is installed at centralized area for providing pure drinking water in the campus.
- The sewage water is discharged in the municipal drain, which is a common practice and corporation charges cess towards the same.
- Water coolers are provided at convenient locations.
- The distribution network and piping are more or less satisfactory and adequate.
- The restrooms are provided with water efficient (low usage) fittings.

Waste Management:

- College is looking at environmental issues very seriously and taking all possible steps towards sustainability.
- The waste is segregated and handled accordingly.
- It is suggested to install composting pit to convert the canteen kitchen and garden waste into organic manure which can be used in the in-house gardening.
- The dry waste is disposed through Municipal System.
- The sewage water is discharged in the municipal drain, which is a common practice and corporation charges cess towards the same.

Air Conditioning System:

- The Air Conditioners are operated as required with manual control. The operation is minimal consequently automation may not be economical.
- The room temperature is maintained at 23 to 25°C, which is well within the recommended values.
- The Air Conditioners are serviced regularly and properly maintained.
- Most of the Air Conditioners units are energy efficient with 3 star rating.

Infrastructure usage:

- The on-campus movement is distributed with multiple entrances as well as staircases.
- There are ramps and lifts at key locations.
- A special assistance is provided to address the needs of differently abled persons.
- The fire extinguishers are provided at key areas.
- The draining system for washrooms is efficient and effective.
- There were no seepages observed in the building premises.

Green IT culture:

- The Energy efficient computers and laptops have been procured.
- The electronic communication is encouraged to minimize usage of papers.
- Most of the papers are reused for doubled sided printing to further minimize usage of paper.

Renewable Energy:

- The Solar Photovoltaic System with net metering has been installed.

RAINWATER HARVESTING

- Water scarcity is serious problem throughout the world for both urban & rural community. Urbanization, industrial development & increase in agricultural field & production has resulted in overexploitation of groundwater & surface water resources and resultant deterioration in water quality. The conventional water sources namely well, river and reservoirs, etc. are inadequate to fulfil water demand due to unbalanced rainfall. While the rainwater harvesting system investigate a new water source.
- In HRPIPER campus a rainwater harvesting system is working. The runoff from the terrace of the college building is channelized into a recharge well located near the building. The runoff from the unpaved area is intercepted at a collection trench. From here the runoff eventually drains into an abandoned open well, which facilitates groundwater recharge.

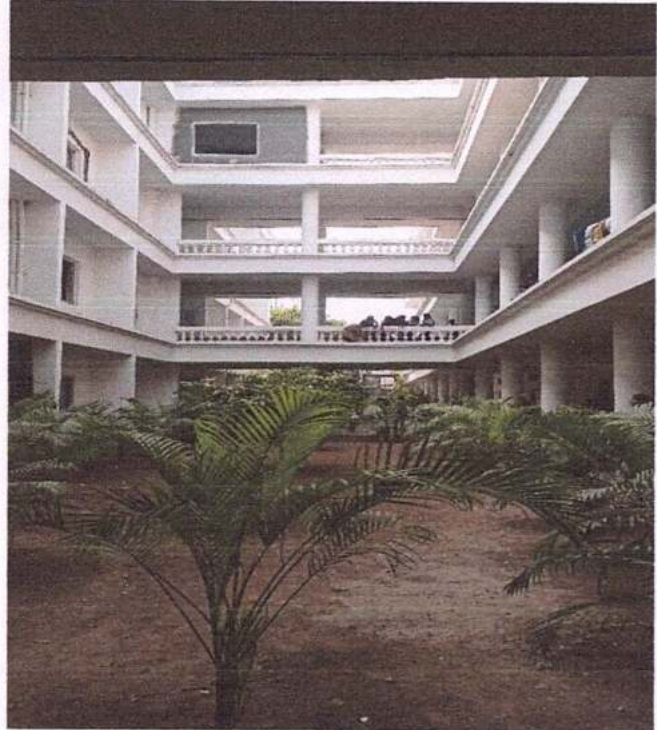

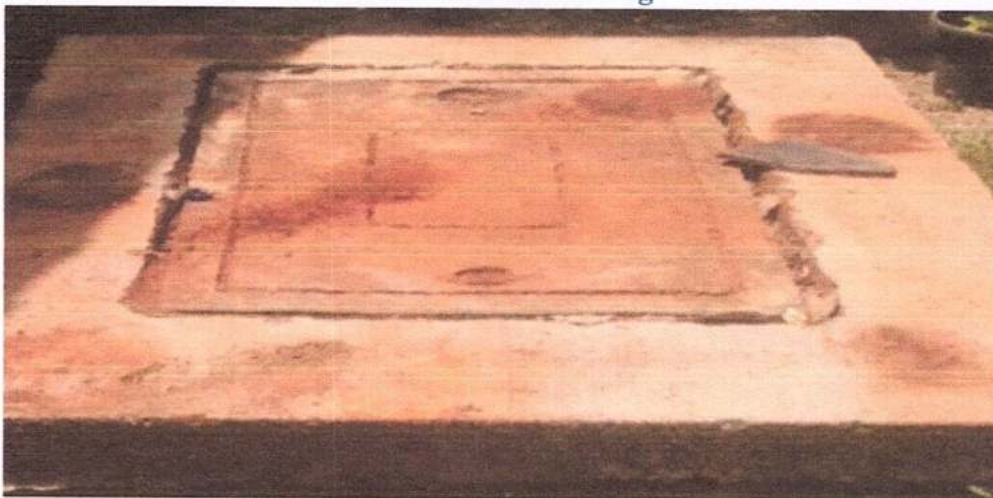



II Executive Summary

The premises were evaluated against the various criteria laid down by the National Assessment and Accreditation Council (NAAC). The major observations are.

Air Quality & Ventilation:

- The classrooms and other areas are well ventilated to ensure proper air quality.
- The fans are appropriately installed to ensure proper air circulation.
- The outdoor and few indoor plants have also been provided to improve the environment.
- The air conditioned rooms are provided with proper ventilation and fresh air.

Lighting System:

- The usage of natural light is optimized through well designed structure and windows.
- Almost all the light fittings are provided with high efficiency LED lamps, the others being replaced with LED lamps.
- It is suggested to automate switching of lamps in the common areas and rest rooms with sensor based control.

Green Campus Initiative:

- The movement of vehicle inside the campus is restricted and sufficient parking space is provided for four as well as two wheeler vehicles.
- The plastic usage is completely banned inside the campus.
- The campus is surrounded with a lot of greenery, trees, and proper landscaping.
- The college has various groups to create awareness and take up activities like tree plantation, cleanliness drives, road shows and other awareness programs.
- The student participation is encouraged in such activities through student clubs and groups.

Environment & Energy Initiative:

- Tree Plantation drive was undertaken by students and staff members.
- Cleanliness drives were undertaken by students and staff members.

Water Quality & Conservation:

- The water is supplied by the Corporation, which is a common practice in cities and towns.
- The RO (Reverse Osmosis) based water purification system is installed at centralized area for providing pure drinking water in the campus.
- The sewage water is discharged in the municipal drain, which is a common practice and corporation charges cess towards the same.
- Water coolers are provided at convenient locations.
- The distribution network and piping are more or less satisfactory and adequate.
- The restrooms are provided with water efficient (low usage) fittings.

Waste Management:

- College is looking at environmental issues very seriously and taking all possible steps towards sustainability.
- The waste is segregated and handled accordingly.
- It is suggested to install composting pit to convert the canteen kitchen and garden waste into organic manure which can be used in the in-house gardening.
- The dry waste is disposed through Municipal System.
- The sewage water is discharged in the municipal drain, which is a common practice and corporation charges cess towards the same.

- The Air Conditioners are operated as required with manual control. The operation is minimal consequently automation may not be economical.
- The room temperature is maintained at 23 to 25°C, which is well within the recommended values.
- The Air Conditioners are serviced regularly and properly maintained.
- Most of the Air Conditioners units are energy efficient with 3 star rating.

Infrastructure usage:

- The on-campus movement is distributed with multiple entrances as well as staircases.
- There are ramps and lifts at key locations.
- A special assistance is provided to address the needs of differently abled persons.
- The fire extinguishers are provided at key areas.
- The draining system for washrooms is efficient and effective.
- There were no seepages observed in the building premises.

Green IT culture:

- The Energy efficient computers and laptops have been procured.
- The electronic communication is encouraged to minimize usage of papers.
- Most of the papers are reused for doubled sided printing to further minimize usage of paper.

Renewable Energy:

- The Solar Photovoltaic System with net metering has been installed.


