**CLAUSE 1**

**CO-OPERATION**

2.3 Placement of trained students: second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.

2.4 There is no financial commitment on the part of the **H. R. Patel Institute of Pharmaceutical Sciences and Research, Shirpur**, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
